James Wong Howe Exhibit

The James Wong Howe Exhibit presented by the Friends of the Museum of Chinese American History received over 1,600 visitors during its two-week duration. It was cosponsored by the Chinese Historical Society of Southern California, the El Pueblo de Los Angeles Historic Monument and the Chinese Chamber of Commerce.

This photo exhibit is based on a production originally created by Beulah Quo, Terry Tam Soon, and Marjie Chan, with the assistance of Gilbert Leong and the support of Sanora Babb Howe. Having been on international tour, the exhibit materials are now part of El Pueblo's Museum of Chinese American History collections. The exhibit space (650 square feet) was donated by Scott Lee of JBL Properties, Inc. The two videotapes shown in the exhibit were provided by Beulah Quo and Robert W. Wagner. The El Pueblo Monument was responsible for the exhibit panels and loaned all artifacts for display.

STANDING RULES OF THE CHINESE HISTORICAL SOCIETY OF SOUTHERN CALIFORNIA

Article I - Major Functions of the Society

The Society's major functions will be the following:

Section I. To discover any material which may help to establish or illustrate the progress of the history of the Chinese in the area.

Section 2. To collect any printed material and artifacts illustrative of life, conditions, events and activities of the past and present.

Section 3. To provide for the preservation of such materials and for its accessibility as far as may be feasible for all who wish to examine or study it.

Section 4. To disseminate historical information and to stimulate interest in Chinese American history through various long and short-term projects.

To cooperate with other historical societies for a broader historical perspective.

Article II - Membership and Dues

Section I. Membership classes and corresponding dues

a. Individual: annual dues for individual members shall be fifteen (15) dollars and five (5) for each additional member of the same

b. Contributing: annual dues for contributing members shall be five (5) dollars.
c. Life: dues for life members shall be two hundred (200) dollars per person to be made in one time payment.
d. Institutional: annual dues for institutional members shall be twenty-five (25) dollars.
e. Corporate: annual dues for corporate members shall be fifty (50) dollars.
f. Life Patron: dues for a Life Patron shall be one thousand (1,000) dollars which is to be a one-time payment.

- Section 2. Members in arrears more than three months in dues shall be dropped from membership.
- Section 3. A member may terminate his membership at any time upon written notice of resignation to the Secretary. Resignation is effective on date of receipt of resignation notice. No refund of membership dues shall be made.
- Section 4. The Society, by action of the Board of Directors, may terminate any membership, except that of an officer or director-at-large, for any willful infraction of the by-laws and other rules and regulations of the Society. No refund of membership dues shall be made.

Article III - Financial Secretary Duties

- Section 1. The Financial Secretary shall deposit all monies received by him with a reliable banking company in the name of the Chinese Historical Society of Southern California
- Section 2. Monies shall be paid out by numbered checks signed by the Financial Secretary and co-signed by the Treasurer or President.

Article IV - Standing Committees

- Section I. The President shall appoint the chairpersons of all the committees and some members of the standing committees. Board members shall be considered for positions of chairpersons first. The chairpersons of all committees shall serve for the duration of the program year until a new chairperson has been appointed and approved. All members of standing committees shall report to the Board.
- Section 2. A person can chair only one standing committee at a time. Officers, directors-at-large or members of standing committees may serve on no more than three standing committees as members.
- Section 3. Standing committees may create sub-committees to carry out tasks within their responsibilities.

Article V - Amendments

Changes in the standing rules can be made at any regular meeting with a quorum of voting members present. A majority vote of those voting members present shall be needed to make Achanges. All proposed changes must be submitted in writing.

Article VI - Dissolution

Upon dissolution of the Society, all collections whatsoever, donated as a collection unit, listed and described below, are to be distributed to organizations of the type defined in the articles of Incorporation. Article VII as controlled by the Bylaws, Article XI.

BYLAWS OF THE CHINESE HISTORICAL SOCIETY OF SOUTHERN CALIFORNIA, INC.

Article I - Name

The name of this society shall be the Chinese Historical Society of Southern California, Inc.

Article II - Purpose

The purpose of this society shall be to bring together those people interested in history, and especially in the history of the Chinese in Southern California at large. Understanding the history of our community is basic to our democratic way of life, gives us a better understanding of our state and nation and promotes a better appreciation of our Chinese American heritage.

The purpose of the Chinese Historical Society of Southern California, Inc. shall be

to bring together people with a mutual interest in the history of Chinese and Chinese Americans of Southern California,

to perform all the functions and activities of an historical society in pursuit of gaining, preserving and communicating knowledge of this important history and

to understand the significant historical role of Chinese and Chinese Americans of Southern California and in America.

Knowing the heritage of our community is basic to maintaining our democratic American way of life and to promoting a better appreciation of our rich, multi-cultural society.

Article III - Membership and Dues

Section 1.	Membership	Eligibility
	war and on the court of	awanga cenay

Any person or entity interested in the history, purposes and activities of the Society shall be eligible for membership in the appropriate category upon payment of the necessary dues. These categories are:

- Individual member
- Contributing member: students and seniors (sixty years of age or over) b.
- Life member
- Institutional member: organizations, boards, schools or libraries Corporate member: business firm or for-profit corporation d.
- Life patron

Section 2. Annual Dues

Annual dues are payable in advance and shall cover the calendar year period.

Section 3. Honorary Membership

Honorary membership may be conferred upon any person who has contributed significantly to the purposes and activities of the Society. Honorary members shall be elected, upon nomination by the Board of Directors, at a regular meeting at which a quorum of voting members is present, by a three-fourths vote of those voting members present.

Article IV - Annual Meeting Article IV - Membership Meetings

There shall be an annual meeting of the Society during the month of April at which time the annual election of the officers and directors at large shall be conducted. The officers elect and directors at large elect shall be installed during the month of June and begin their term of office the following July-1.

- Section 1. There shall be a minimum of six (6) meetings during the program year.
- Section 2 A minimum of ten (10) paid up members shall constitute a quorum.
- Section 3. Special meetings may be called by the president with Board approval or at the written request of five (5) paid up members of the

Society.

Section 4. The April meeting shall be the annual meeting.

Service period:

Article V - The Board of Directors

- The officers and directors-at-large together shall constitute the Board of Directors. Section 1.
- Section 2. Number: The Board of Directors shall consist of no less than twelve (12) members and no more than sixteen (16) members

Section 3.

- The service period is from July 1st to June 30th of the following year.
- Officers: The service period for all officers shall be for one year and all officers can be re-elected to the same position once.
- Directors-at-large: There shall always be two classes of directors-at-large, one of which shall expire each year. The service period shall be for two years.

- Any officer or director-at-large who has served more than six months within a program year shall be considered to have served a full year.
- Section 4 Duties of the Board of Directors
 - The Board of Directors shall decide questions of policy and conduct all the affairs of the Society that for any reason cannot be acted upon at a meeting of the Society and perform such other functions as designated in the bylaws or otherwise assigned to it.
- Section 5. Meetings and Quorum
 - Meetings: There shall be a minimum of six(6) regular meetings of the Board during the program year.
 - Quorum: A simple majority of the Board membership shall constitute a quorum to conduct business. b.
 - Special meetings of the Board of Directors may be called by the president or by a written request of a majority of the Board.
- Section 6. Vacancies
 - a. All vacancies of officers or directors at large shall be filled by a special election.
 - Except for president, all vacancies of officers or directors-at-large shall be filled.
 - (1) Before mid-year by special election (2) After mid-year by the Board
 - b .-- The officer elect or director at large elect shall serve out the balance of the service period.
 - The replacement officer or director-at-large shall serve out the balance of the year.
- Section 7. Removal of Directors
 - An officer or director-at-large shall be removed from office before expiration of his/her service period if it is determined by the vote of the membership of the society that such officer has been guilty of misconduct in office.
 - Misconduct in office shall be the sole grounds for which an officer or director-at-large may be removed from office. The term "misconduct in office" shall be defined to include, but is not necessarily limited to the following acts: b.
 - Commission of a crime involving moral turpitude. Abuse of the powers entrusted to the director office. (1) (2) (3)
 - Any other conduct contrary to the interests of, or tending to cause disrepute to the Society.
 - The removal of an officer or director-at-large can be initiated through the creation of a committee by the Board or by vote of the Society, a quorum of voting members being present at a regularly scheduled meeting.
 - (1)The motion shall name the five members of the committee and a convener or chairperson and the committee shall report back within two months with its recommendations and findings.
 - (2)An officer or director-at-large can be removed only by the Society at a regular meeting, at which a quorum of voting members is present, by a two-thirds vote of those voting members present voting.

Article VI - Officers and Directors-at-large

- Officers Section 1.
 - The officers shall be, in the order of succession, the President, Vice-President, Secretary, Treasurer, Financial Secretary and Membership Secretary.
 - All officers shall be elected for the service period of one year, shall hold office until their successors are elected and can be re-elected to the same position once.
 - The President, Vice President and Secretary can serve for a maximum of two (2) consecutive service (1) periods (two years), after which one year must elapse before the person can be re-elected to the same office. Any of the above officers who have served more than six months shall be considered to have served a full service period (one year) in that office.
 - The Treasurer, Financial Secretary and Membership Secretary have no limit to the number of consecutive (2)service periods they can serve in the same office.
- Section 2 Directors-at-large
 - Directors-at-large shall serve for no more than three (3) consecutive two-year service periods (six years), after which one year must elapse before the person can be re-elected as a director-at-large.
 - Any director-at-large who has served for six months or more in any twelve months program period shall be considered to have served a full year.
- Section 3. Duties of the Officers
 - The President shall have executive supervision over the activities of the Society provided by these bylaws. The President shall preside at all meetings of the Board of Directors and at Society meetings, shall report annually to the membership on the activities of the Society and shall appoint chairpersons and members of the committees and delegates not otherwise herein provided.
 - The Vice-President shall assume the duties of the President in the event of absence, incapacity or resignation of the President.
 - The Secretary shall keep the minutes of meetings of the Society and the Board of Directors, shall have responsibility for the Corporation seal and legal records of the Society, and shall serve all notices to the membership required by these bylaws, state and federal laws and shall maintain the correspondence of the Society.

- d. The Treasurer shall be the chairperson of the Finance and Assets Committee. The Treasurer and the Financial Secretary shall make a semi-annual and an annual year-end report to the Board of Directors.
- The Financial Secretary shall be responsible for the safekeeping and maintenance of accurate records of the Society finances. The Financial Secretary shall

(a) collect income, deposit funds and disburse payment for expenses
(b) coordinate with the Membership Secretary to maintain accurate

- coordinate with the Membership Secretary to maintain accurate records of members' dues and related information
- (c) make, with the Treasurer, a semi-annual and an annual year-end report to the Board of Directors and (d) Serve as a member of the Finance and Assets Committee.
- f. The Membership Secretary shall process new candidates for membership, provide appropriate continuing services to members, maintain a membership list with suitable supporting information, maintain mailing lists for Society functions and conduct drives for additional membership.
- g. The All officers shall perform other duties as provided by the bylaws or as required by the Board of Directors.

Article VII - Nominations Committee and Elections

Section 1.

Nominations Nominating Committee

- a. The President shall appoint, a Nominations Committee with Board approval of three or more active members. with Board approval, a nominating committee and its chairperson. The Committee shall publicize the list of nominees for officers and directors at large to the membership at least thirty days prior to the election. All nominees must be paid up members and must give their consent in order to be placed on the ballot.
- b. The nominating committee shall include a chairperson and two (2) or more paid up members of the Society but shall not include more than two (2) present officers.
- c. The nominating committee shall report to the membership meeting one (1) month prior to the elections, where additional nominations from the floor shall be accepted. Nomination shall then be closed.
- d. There shall be no more than six (6) directors-at-large held over to complete two (2) year terms. The nominating Committee may cut short any director-at-large term when more than six (6) are at mid-term.

Section 2.

Elections

- a. The election of officers and directors-at-large shall be held at the Annual membership meeting. The election shall be conducted by the chairperson of the Nominations Committee.
- b. The election of officers shall be conducted first. The announcement of elections with the nominees shall be published at least two (2) weeks before the elections.
- The election of directors at large shall be conducted second. The elections shall be conducted by the nominating committee chair.
- d. Only paid up members are eligible to vote.
- e. A-majority of the votes cast shall be needed to elect officers and directors at large. The elected officers and directors at large shall be installed during the month of June and shall begin their term of office on July 1.

Article VIII - Committees

Section I. Standing Committees shall have three or more members.

Section 2. The Standing Committees are these:

a. Archives Committee

The Archives Committee shall be responsible for (1) collecting, cataloging, care, arrangement, access and repair of books, manuscripts, newspapers, archival and other historical source material; (2) the collection, cataloging, cleaning, repair and access, and storage of archival and historic objects; (3) for the care of the written, audio and visual records of the Society, and for the care and upkeep of quarters containing the above resources.

b. Publications Committee

The Publications Committee shall be responsible for developing and implementing Society publications, such as but not limited to, brochures, a newsletter, journal(s), books and research studies.

Historic Research and Recognition Committee

The Historic Research and Recognition Committee shall be responsible for planning, developing and conducting research programs; for establishing the historic validity for sites, events, persons, or institutions proposed for identification as historical; for marking historic sites; for recognizing historic events, persons, or institutions.

d. Program Committee

The Program Committee shall be responsible for coordinating, arranging and implementing programs, meetings, dinners, field trips and other activities.

e. Finance and Assets Committee

(1) The Finance and Assets Committee shall be responsible

- (a) for the management of all funds, real property, equipment and all other assets,
 (b) for the development of short and long range planning, investment objectives and financial
- policies,
 (c) for the management of adequate and accurate financial and assets records and reports,
 (d) for the management and maintaining of necessary corporation records and filing of necessary
 papers with public entities such as the corporation filing fee, federal and state income tax
 returns and California sales tax returns and
- (e) for the recommendation of policies to the Board relating to finances and assets.
- (2) The Finance and Assets Committee shall work together with other standing committees to help other committees with their responsibilities where finances are involved.

f. Outreach Committee

The Outreach Committee shall be responsible for education, public relations, historical tours, exhibits and community participation.

Section 3. Special Committees

Special Committees may be created from time to time to carry out functions not included in standing committees.

Article IX - Parliamentary Authority

The rules contained in Robert's Rules of Order, Newly Revised, shall govern the proceedings of the Society except in such cases as are governed by the bylaws.

Article X - Amendments to the Bylaws

These bylaws may be amended at any regular meeting with a quorum of voting members present, by a majority vote of those voting members present. Notice for the amendment must be given at the previous meeting. All proposed amendments must be submitted in writing AND PUBLICIZED.

-- Article-XI--Schedule and Quorum for Membership Meetings

Section 1.—————There shall be a minimum of six meetings during the program year.
Section 2. Special-meetings may be called by the President at the written request of five (5) paid up members of the Society.
Section 3.———Special-meetings of the Board of Directors may be called by the President
Section 4.—————A-minimum of ten (10) paid up members shall constitute a quorum.
Section 5.————A voting member is one who has paid his current dues.

Article XH XI - Dissolution

Upon the dissolution of the corporation, its assets remaining after payment of, or provision for, payment of all debts and liabilities of this corporation, shall be distributed to any nonprofit fund, foundation, or corporation which purposes are similar to this corporation.

Upon the dissolution of the Society:

- L. After payment of all debts and liabilities of the Society, all remaining assets shall be distributed as directed by the Articles of Incorporation.

 No Society member, individual or group of individuals shall profit from this dissolution.
- 2. All collections, archives, and artifacts shall be distributed to those organizations as defined in the Articles of Incorporation.
- 3. All collections, donated as a collection unit, and listed in the Standing Rules- Section IV, shall be distributed only as a single collection unit never to be separated.
